  - 6.2 Risk Management Unity Aquatics:
    - a. Dan gave overview of where Unity is with the pool policy. 15 and under are not allowed to swim unless there is a lifeguard on duty.
    - b. Jenna F requested the pool be open earlier hours for younger families and children.
    - c. Tiffany S would really like to be able to take her kids swimming during the day
    - d. Val W stated she has been bring her daycare kids and teaching them to swim for 25 years. She stated they always follow the rules, and feel they are being penalized for others. Would like to see a form so parent/guardians are allowed to watch youth when there is not a lifeguard present
    - e. Hisa said she has been bringing her kids for years for therapy and that her kids do not like to come during open swim and like to swim laps and feels it is unfair that she cannot be responsible for them while they are in the water without a lifeguard.
    - f. Suggestions that were given: only members are able to access pool area when lifeguards are not present, a waiver system, a wristband system
    - g. Public would like to see more day time hours available, especially after school
    - A motion was made by Steve for a committee to follow up on the waiver to present to the board at a special meeting that would allow it to be presented to the city council. The committee will be Brian S, Keith W and Heidi W. Seconded by Rondi. Motion passed
      - i. Committee will look at the schedule, swim risk, and limits on open swim
