MILBANK CITY COUNCIL PROCEEDINGS April 8, 2024, 7:00 pm

Call to Order - The City Council met in regular session on April 8, 2024, at 7:00 pm in the Visitor Center, 1001 East Fourth Avenue, Mayor Raffety presiding.

Roll Call - Mayor Raffety. Councilmembers: Mike Hanson, Roger Briggs, Josh Karels, John Weyh, and Craig Weinberg. Absent: Mindy Rogers. Staff Present: Mark Reedstrom, Steve Pendergrass, Cynthia Schumacher, Corey Hooth, Darin Thiele, Ron Krause, Dick Poppen, Jesse Morton, Cody Pohlen, and Don Settje.

Public Present: Holli Seehafer, Dane Ekdom, Kevin Cantine, Greg Cantine, Alex Pauli, and Kathy Ward.

Don Settje was recognized for his 25 years of service with the city water department. Mayor Raffety congratulated Trey and Abigail Jankord on their recent wedding.

Dane Ekdom, ISG Engineering, presented a draft of the Capital Improvement Plan (CIP), highlighting key items of the city's infrastructure, public buildings, streets, and parks that should be considered for near future improvements. He clarified that the document is intended to assist in budget preparation and that the Council's approval of the final plan does not signify a financial or project commitment.

Action Items -

- 1. Parks & Recreation Director Pohlen discussed the need for improvements to the Cantine Tennis Courts, which have deteriorated over the years due to weather conditions. The council considered the conditions of the existing courts and explored the possibility of adding additional courts with pickleball lines or relocating the courts. Pohlen stated additional courts would allow for larger high school tournaments, USTA day camps, growing youth tennis lessons, and increasing pickleball opportunities. After considering options and locations, the board recommends resurfacing the existing courts and adding two additional courts to the southwest of the current courts. Concerns addressed included the loss of parking spots and whether the current location was an appropriate location for expansion. A motion was made and seconded to approve the proposal to resurface the existing four courts, add two new courts at the current location, and call for bids as needed. Motion carried 4-1. Aye: Briggs, Hanson, Karels, Weyh. Nay: Weinberg
- 2. A motion was made and seconded to approve the second reading of Ordinance 851-Establishing Special Flood Hazard Areas. No comments were made. A motion carried by roll call vote 5-0.
- 3. A motion was made and seconded to approve the first reading of Ordinance 852-classify property as Light Industrial District, I-1. No comments were made. A motion carried by roll call vote 5-0.
- 4. A motion was made and seconded to approve Resolution 4-8-24, Annex property into the City of Milbank. Motion carried 5-0.

RESOLUTION NO. 4-8-24

A Resolution Annexing Certain Real Property into the City of Milbank, Grant County, South Dakota.

WHEREAS, Arvid & Janet Liebe, owner(s) of real property in Grant County, South Dakota, currently outside city limits and described as:

Lot 21 Milbank Industrial Park Second Addition in the SE 1/4 and Lot 1 Redman's Third Addition in SE 1/4, except Lot 4 Berkner's Addition, and except Lots 1 and 2 Twin Valley Tire Addition, and except that portion of Lot 1 Redman's Third Addition in SE ¼ lying north of the southern border of Lots 1 and 2 Twin Valley Tire Addition as recorded in Plat Case 004 Plat No. 254, in Section 12, Township 120 North, Range 49 West of the fifth PM, Grant County, South Dakota, which upon platting will be known as the Plat of Milbank Industrial Park Third Addition Located in the City of Milbank and in the SE1/4 of Section 12, Township 120 North, Range 49 West of the 5th P.M., Grant County, South Dakota changes to the Zoning Ordinances of the City of Milbank

Chief Hooth complimented staff and the newly implemented fleet management program, stating having the squads managed and serviced in house has been working well.

- 8. A motion was made and seconded to approve bids for street materials, schedule 1, 2, 4 submitted by Bituminous Paving Inc.
- Bid Schedule 1 750 tons hot mix bituminous material, picked up, \$81.00/ton.
- Bid Schedule 2 6,650 tons asphalt, machine laid, \$83.00/ton.
- Bid Schedule 4 asphalt milling, two-inch depth, 12,500 sq yd, \$3.30/sq yd.

No other bids were received. Motion carried 5-0.

J&J Earthworks submitted the only bid for bid schedule 3, 6,000-ton aggregate base course material to be delivered - \$14.85/ton. A motion was made and seconded to reject the bid and rebid. Mayor Raffety stated the bid is almost double from 2022. Motion carried 5-0.

Department reports -

Initially bond funds were allocated for an expansion to Unity. It has become evident that the funds are inadequate for a full expansion. The Council requested the CIP be reviewed with the Park Board and consider reallocation of bond funds to address the outlined items in the CIP.

City Administrator Pendergrass reported the city has been approved for a Hazard Mitigation Grant for the construction of a storm shelter at Lake Farley.

Updated estimates for the water project are lower than originally expected. No timeline is available currently.

The Council requested PWD Theile to get an update from Valley Queen pertaining to the construction and reopening of Third Avenue.
