

## LAKE FARLEY CAMPGROUND - CAMPING AGREEMENT

### STORM SHELTER IS THE BATHROOM BUILDING NEAR THE NORTH ENTRANCE OF THE PARK

1. CAMPGROUND: The campground is open from May 15 to approximately October 15, depending on the weather.
2. CAMPING RATES:

Camping rates including water, sewer and electric (30 & 50 amp):

Sites 1 – 7	\$30/night – <i>UNAVAILABLE DURING THE 2024 SEASON</i>
Sites 8-15	\$35/night – LIMITED TO 14 DAY STAY
Site 16	\$25/night – Handicap Site Limited Stay
Sites 17-29	\$25/night or \$600/Four Weeks (Monthly) – DAILY AND MONTHLY STAY AVAILABLE

Campsites must be vacated or re-registered if available by 2:00pm.

3. CANCELLATIONS & REFUNDS:  
Cancellations earlier than 14 days before scheduled check-in: refund will be given less \$10 cancellation fee.  
  
Cancellations after 14 days of scheduled check-in: a refund will not be given.
4. CAMPING PERMITS/RESERVATIONS: Camping permits shall be obtained online at [milbanksd.com](http://milbanksd.com) or by stopping in or calling Unity Health & Fitness, 904 E. 4<sup>th</sup> Ave. during normal business hours (Monday-Friday, 5:30am – 8:00pm. Saturday 8:00am – 5:00pm).

**Payment is due in full at the time of registration.**

5. RENTERS RESPONSIBILITES: Please clean up any debris left at your camping location.
6. SAFETY: No obstructions shall be permitted in exits such as would hinder entering or exiting the camping areas.
7. PETS: Pets must be on a leash no longer than 10 feet and must be accompanied by the owner at all times. Owners must immediately and thoroughly clean up after their pets.
8. SMOKING: The City of Milbank is committed to the quality of life. Through voluntary compliance, the City of Milbank encourages renters to refrain from using tobacco products on city property.
9. ACTIVITIES: The City of Milbank reserves the right to control all activities and to eject any person(s) disregarding the rules and regulations of the facility. This includes but is not limited to loud music or disorderly conduct. In such a case, fees will not be refunded.

10. **DAMAGE:** Campers shall be financially responsible for all damage to facilities and grounds as a result of their use. Please respect your camping location.
11. **LAWS:** The camper shall abide by all local ordinances as well as state and federal laws.
12. **LOSS OR DAMAGE:** In making available a camping location, the City of Milbank assumes no responsibility for: a) Loss or damage to any property placed on the premises by the camper. b) Loss or damage to any property or personal effect, including motor vehicles and their contents of the renter, its members, employees, agents, participants, guests, or attendees.
13. **HOLD HARMLESS AGREEMENT:** The renter, leaser, or user indemnifies and holds harmless the City of Milbank, all its officers, employees, volunteers, and agents against all claims, losses, or liabilities arising from the use of said areas arising from but not limited to the actions of the activity but also from the general use of the camping site.
